Patient reports that she stopped taking her medications 6 months ago due to cost. She had recently lost her job and stopped taking medications due to finances. Patient notes that her mood has been unstable with anxiety and poor sleep. She notes anxiety and sleep were better managed when on medication. She denies recent SI, plan and intent. She denies violent thoughts.

Patient provides verbal consent to restart Prozac 20mg daily.

Current suicide risk assessment estimated to be low. She is denying any suicidal ideations. Denies history of suicide attempts or self-harm. She is motivated for treatment.
